Registration Terms & Conditions: EACR 2021 Virtual Congress

Language and Translation

The official language of the Virtual Congress is English. Presentations will be delivered in English and no translation service will be provided.

Certificate of Attendance

All registered participants will be able to download a Certificate of Attendance after completing a short online survey immediately after the Virtual Congress. Participants will need their unique and individual log on credentials to track attendance and to download their Certificate of Attendance.

Confirmation of Registration

Upon finalizing your online registration and completing payment, you will receive an immediate email acknowledgement and confirmation including all the details of your Virtual Congress registration.

2 days before the Virtual Congress you will receive an email including updated information on the programme as well as your individual log on credentials and instructions. This email will allow you to access the Virtual Congress Platform and Virtual Congress sessions and content.

Payment Deadlines and Conditions

Paying the Correct Rates

Participants are expected to pay the correct registration rate that applies to them. If an incorrect registration rate is paid in error, we will require the correct rate to be paid in order to finalise your registration.

Member rates (EACR Member, EACR Early Career Member, and EACR Student Member) apply to those who are current members of the EACR, in the relevant category of membership, at the time of registration.

Industry rates apply to participants who work for a for-profit company and are funded to attend the meeting by that company. If they are a current EACR member, the member rate will apply.

Replacements and Cancellation Policies

All cancellations must be made in writing to the EACR 2021 Registration Team via email eacr@newway-management.com. Cancellation requests received within 14 days of confirmation are free of charge. Cancellations received after 14 days of purchase but before 04 June 2021 are subject to an administrative charge of 50 EUR.

For cancellation received after 04 June 2021, no refunds will be made. All refunds will be processed post EACR 2021 Virtual Congress.

Replacements (= participant change) of a confirmed registration can be made and are subject to a 50 EUR administrative fee.

In the event of serious, special or unforeseen circumstances beyond EACR's control and other than Force Majeure, the organiser shall be entitled to cancel the Virtual Congress. Registered participants shall not be entitled to seek compensation for any costs or damages incurred other than the registration fees paid to the EACR which will be reimbursed to the registrant.
